I. Call to Order and Roll Call:

- a. The meeting was called to order at 7:07 p.m., by Chairperson Dan Ferguson.
- b. Board Members Present: Dan Ferguson, Gaylene Ferguson, Ellen Meshefski, Patty Pawelek, Tonya Roland, Jon Gift, Lorilee Munster. (Rhonda Smith and Danny Smith absent)
- c. Citizens Present: Cliff Eklund (Council Liaison), Donnetta Skinner (Council Liaison), Vonda Clancy, Hannah Clancy, Taylor Messenger, Joanna Messenger, Kurstin Robbins, Tori Clancy, Karla Jones, David Jones, Ruth Hart, Don Cox, Ben Gunnels, Rose Gift, Nicole Wolfsteller.

II. Awarding Prizes for the Spook Walk. (Non-Action Item)

- 1. Ellen Meshefski thanked everyone for all their help. She listed the awards as follows:

- 2. Chairperson Dan Ferguson stated there were close to 1,000 people, it took the whole community, as a whole, to put this thing together and make it happen. Ellen Meshefski stated they gave out 196 bands. 196 people just worked inside the cubbies, and that doesn't include those that didn't get a band.
- 3. Ruth Hart gave a hand to Parks & Rec., for their hard work.

III. Review and Possible Approval of Sponsoring a Grand Prix Motor Cross Event. (Action Item)

- 1. Don Cox stated he's been talking about this Grand Prix with Bill Kohbarger, and other people over the last few years. Now he feels it's time to give it a shot. Grand Prix definitions -
 - Cross Country
 - Town
 - Race Track

There's only six (6) of them in the Country, that's why a Grand Prix is a cool thing. There's not very many people interested in doing it or want to tackle the

management of it.

- 2. Bill Kohbarger stated he's the one who put together the map. He explained the area for the race to take place, three (3) laps -10 miles.
- 3. Cliff Eklund stated the main factor is safety and they have 24 hour shifts working in Carlin, which includes daytime sleepers.
- 4. Ben Gunnels stated according to Nevada Commission on Tourism, each race team spends an average of \$300.00 a day, in the town they're in. Cliff Eklund stated he has no problem with the race. If they can come up with a suitable route, he'll be one of the biggest supporters, but if they don't come up with an agreeable route, then he won't be able to support it. Chairperson Dan Ferguson asked Don Cox if what he wants from them is a yeah or nay, so he can go on to the next hurdle?

 Don Cox confirmed yes, so he can begin the applications for permits. They are looking at the first weekend in May.
- 5. Karla Jones asked Don Cox, when he goes to promote something like this, will he be promoting for Carlin, or will it be 23 miles west of Elko?

 Don Cox stated the race track is Carlin Race Track, he hasn't promoted an event in Elko since 1998, and he doesn't plan to start now.
- 6. Tonya Roland stated she has been to one of these before, he may say 1500 bikes, but there's thousands and thousands of people.
- 7. Chairperson Dan Ferguson stated he thinks this is a perfect thing for this country. He does have concerns about going through town, but if they can work out a deal with the Council, then it's okay with him as long as the Council approves the small track through town. These things get huge.
- 8. Motion made by Jon Gift to Grant Don Cox the go ahead to Proceed with the Carlin Grand Prix Motor Cross. Seconded by Lorilee Munster. Motion carried.
